Consent Form

Transportation and Storage of Firearms and Ammunition in accordance with the Firearms Control Act 60 of 2000 and all its amendments

South Africa's current firearms regulatory framework consists of the Firearms Control Act 2000 & subsidiary legislation 2004 (FCA)

(Section 73(2), 74, 76, 77, 78, 80, 81 and 82 of the Firearms Control Act, 2000 (Act No 60 of 2000)

This framework imposes strict substantive and procedural requirements for obtaining a competency certificate, license, permit, or authorization to possess a firearm, to deal in firearms, or to carry out other firearm-related activities, including transportation & or a hunting business, as well as the prescribed firearm safe that meets the standards set by the South African Bureau of Standards. The Registrar of the "SAP" South African Police is authorized to license the following kinds of firearms in this category:

License to Possess Firearm for Dedicated Hunting and Dedicated Sports Shooting

- a handgun, rifle,
- or shotgun that is not fully automatic,
- a semiautomatic shotgun with the capacity to fire a maximum of five shots before it has to be reloaded;
- Or a barrel, frame, or receiver of any of these firearms.
- Only 1 weapons of the same caliber

Prohibited firearms which may NOT be imported into South Africa include:

- Any fully automatic weapon
- Any semi-automatic weapon
- Handgun(s) for self-defense
- Weapons which fall under military categories
- 2 or more weapons of the same caliber
- Less than 21 years of age are not allowed a weapon.

In order for us to transport/storage your firearm we will require the following documents and information.

- ✓ Passport Copy
- ✓ SAP 520 Permit
- ✓ Flight Itinerary / E-Ticket
- ✓ Signed Consent Form (QF-02-002)
